 - Sixteen projects are currently in the construction phase.

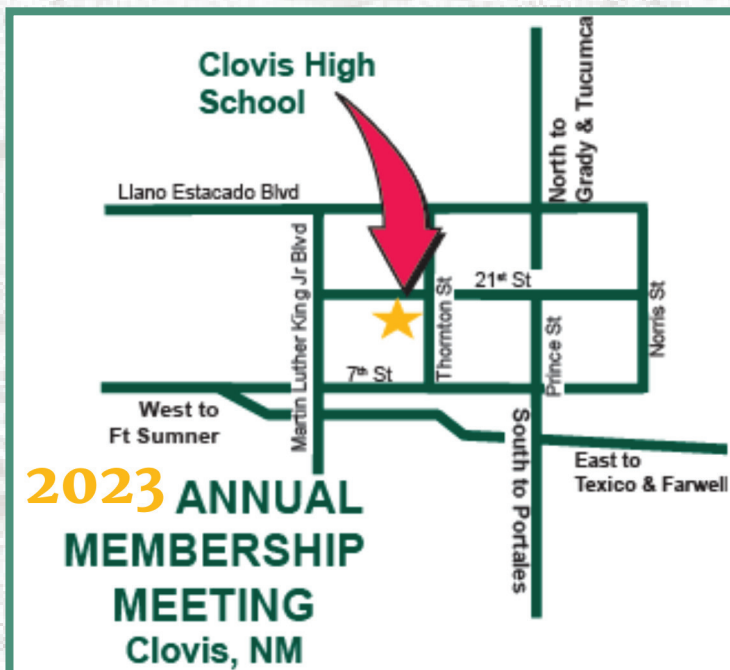

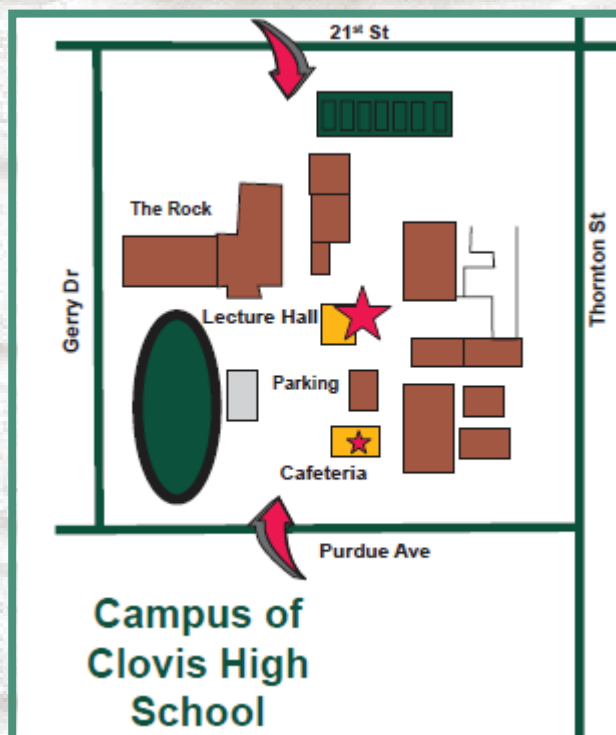
